### Report on the KGB Hazing Committee

*The Ad Hoc KGB Ethics Committee*

Hazing. A phenomenon which, though widely discouraged by universities, still occurs in some organizations. But, god forbid, does hazing occur within the KGB?

A special session of the Ethics Committee was convened to discuss the possibility of hazing within the organization. The meeting was prompted by comments made by one Henry Hausmann, a known Maine resident, at a meeting earlier in the month. Imploring the general body not to arrive at his house at an ungodly hour, he warned that if anyone should arrive at 9A.M., they would be "greeted by the KGB Hazing Committee."

The Ethics Committee immediately voted to undertake investigative measures, which began speedily. Interviews were conducted. Inquiries were made. The following are the findings of this report:

- It is unclear that the KGB Hazing Committee has ever, in fact, been formed, had any members, held any proceedings, or made any reports. While this does seem to exonerate the Committee from any accusations of wrongdoing or even existence, the ethics of the Committee are still in question.
